### Development Activities Report Submitted by Erin O’Gara Dollard

#### Development Repositioning Efforts

In light of the rapid spread and ongoing threat of COVID-19, we have made the decision to unite our LoveBash for Animals and Yappy Hour summer event into a single Virtual Yappy Hour on July 12. We invite you and your pets to join us virtually, for a week of inspiring stories, an online auction, special guests and exciting surprises. More details will be forthcoming in our social media efforts. A safe-the-date postcard will be mailed to all donors in early June.

#### Pet Protection Fund

We are happy to announce the newly created Pet Protection Fund. To date board contributions towards the fund are approximately \$90,000. This fund will be introduced through a direct mail and electronic appeal in June as a “match campaign” and will be announced at the summer virtual Yappy Hour event. This newly created fund will allow the Potter League to continue to provide essential programs and services to homeless animals and the people who love them. Money raised for the Fund will also help those in our community who have fallen on difficult economic times, fallen ill due to COVID19 and can no longer care for their pet or need financial assistance to do so.

#### New Donors & \$100+ Donor Reports

You will notice each are titled “part 2”. The reasoning for that is because our reporting for the April Board meeting reflected gift in early April in response to the beginning phase of COVID19. During that time a number of private donors and foundations made significant gifts in the first few weeks of the month, so there is overlap in reporting. #### Grant & Foundation Update

We continue to apply for emergency funding where available in addition to our planned applications for FY20. Many trusts and foundations have adjusted their time-lines and deadlines in light of the coronavirus and some have sped up the process in order to expedite funding sooner than their usual distribution date.

#### Van Beuren Charitable Foundation

We continue to participate in the 2020 Fund Development Practices Cohort via conference calls and Zoom meetings. Virtual meetings are planned through the summer.

#### 401 Gives

On April 1<sup>st</sup> we participated along with 300 non-profits statewide to participated in this on-line day of giving campaign organized by the United Way of Rhode Island. This digital campaign is

similar to Giving Tuesday. By participating, had the opportunity to secure funding from state wide donors. Our efforts raised approximately \$5,000.
